

I am writing on behalf of the Otsego County Board of Representatives to express our enthusiastic support for the City of Oneonta's Downtown Revitalization Initiative proposal. I am pleased to write a letter of support for the City of Oneonta's Downtown Revitalization Initiative Application. As an Urban Sociologist I can tell you that a city's downtown is more than another neighborhood: it is typically the symbol of the entire community and the surrounding region. Oneonta is a city that serves as the symbolic capital of the region south of the Mohawk Valley, and it is well poised to capitalize on past plans and current strengths to serve as a beacon of social and economic strength for the region as a whole.

Oneonta is nearly an hour from other major urban centers, and as a result is fast becoming a major retail center for a perimeter of about thirty miles in any direction. The commitment by city and other area officials to a vibrant urban core in the city has resulted in considerable fiscal and time investment aimed at plans to create a downtown attractive to residents and visitors alike. Such a downtown would help attract both professionals and students to SUNY Oneonta as well as Hartwick College.

A healthy downtown core composed of retail, entertainment, and housing will enhance quality of life, and quality of life is a potent recruitment tool. SUNY Oneonta has identified a need for more market rate rental properties, particularly aimed at professionals just beginning or ending their careers, and this provides an opportunity to revitalize downtown in the process. The College has engaged in discussions aimed at building constructive town-gown relationships. In recent years SUNY Oneonta has convened a task force to examine the role of the College arts programs in potential downtown revitalization, and we are now prepared to further pursue their ideas. The College is home to experts in urban development and entrepreneurship who are prepared to offer their assistance, and SUNY 2020 offers exciting potential to have a positive impact on the community beyond the niche market created by our 6,000 students.

Downtown Oneonta has been the subject of much investment and effort over the preceding several years. Main Street already provides a vitality of entertainment and retail options that many communities would find enviable. With extra investment from New York State, Oneonta can implement its plans, turn the tide, and become a showpiece of small city urban vitality.

I wish the City of Oneonta success in this endeavor and we look forward to looking more into the City as a potential investment opportunity.



The mission of the Foothills Performing Arts and Civic Center is to enhance the artistic, cultural, educational, and economic climate within the Oneonta community and the Central New York Region. To that end, we would like to join with City of Oneonta to support the Downtown Revitalization Funding Project so we might all work together to accomplish our common goal of creating an entertainment district in the heart of Oneonta.

We are committed to making Foothills a center for community involvement and civic engagement. By offering a high-quality performing arts schedule and making FPAC a leading destination for event planning and business meetings, we integrate with the local community in many ways, bringing business and increased visibility to our area restaurants, hotels, and stores; and ensuring ongoing collaboration with arts groups, tourist attractions, other entertainment venues, and economic development agencies throughout the region.

We strive to provide performing arts and educational programs that reflect our local community, with a focus on introducing theater, music, and other arts to young people across the area.

In 2000, leading citizens from various sectors of the city of Oneonta incorporated the Foothills Performing Arts and Civic Center, a forum for cultural and civic activity conceived to serve the needs of Chenango, Delaware, and Otsego Counties in central New York. Following the acquisition of a site on Market Street in the city's historic downtown district, the initial phase of construction was completed with the opening of the Production Center in 2005. Foothills Performing Arts and Civic Center is a public, not-for-profit 501(c)(3) charitable institution, exempt from federal taxation. Its primary mission is to provide cultural enrichment to the tri-county area (with an eye, eventually, to an even wider radius), not only in terms of arts events, but in educational and outreach initiatives as well, thus stimulating the economy in diverse ways: attracting and retaining professionals and businesses, and helping to keep young people in the area after college.

The tri-county region at the heart of the Foothills Performing Arts and Civic Center's focus is exceptionally rich in artistic and cultural activity. Foothills Performing Arts Center is emerging as a magnet for many artistic events through collaboration with booking agents, or produced by renting organizations.
