**Permit Application for Consumption of Alcoholic Beverages in Oneonta City Parks
 (Revised June 2012)**

As per § 220.2 (C) (1) of the Code of the City of Oneonta, alcoholic beverages are not allowed in city parks except by special permit issued by the City of Oneonta.

The following form must be completed and submitted to the City of Oneonta Parks and Recreation Commission via the City Clerk's Office and will be considered by the Parks and Recreation Commission at its regularly scheduled meeting held on the first Monday evening of each month at 7:00 p.m. Your attendance is NOT required, however, if the commission has questions regarding your application you may be asked to appear or answer additional questions regarding your event. NOTE: Meals should be finished at approximately 8:00 p.m. in order that all clean-up work is completed by the time the park closes at 10:30 p.m.
