 4. Link Caboose to walkway system. Enhance caboose display. Incorporate decorative pavers. Limb up surrounding trees to increase visibility. Founder's memorial trees to remain.
 5. Relocate shed and implement facade improvements.
 6. Relocate Swings & Playgrounds
 7. New Sand Volleyball Court
 8. Relocate basketball court & buffer plantings
 9. Preserve and Enhance existing picnic areas with new tables, grills, benches, & plantings.
 10. Living Memorial Plantings

 12. Reduce pavement and reconfigure drive lane
 13. Reconstruct asphalt drive
 14. Add topsoil and smooth grades

 1. New bituminous asphalt walks
 2. New walkway around Hodges Pond
 3. New Performance Stage

 6. Incorporate shade tree Grove
 7. Reduce edge of pond along roadway to allow for walkways
 8. Repair edges of pond
 9. Redefine parking limits / new striping

 1. New Concrete Walks
 2. Tot splash area / Shade structure
 3. Big kids splash area
 4. Playground with synthetic surfacing
 5. New Picnic Shelter
 6. New Parking Lot (75 spaces)
 7. New Tree Planting to define spray park lawn area
 - D - Dog Park**
 1. +/- 3.1 Acres (+/- 2.0 Acres lawn, +/- 1.1 Acres wooded) (Small dog play area +/- 0.6 acres, Big dog play area +/- 2.5 acres)
 2. Small open air shelters (2)
 3. Double entry gate
 4. Buffer plantings
 - E - Market Street Park Entry**
 1. New Entry Sign with plantings, new sidewalk curbing, & street trees
 2. Improve walkway connections to park
 3. New Concrete Walks
 4. Widen bridge min. 5' clear walk width.
 - F - River Street Park Entry**
 1. New entry sign with lights and plantings
 2. Maintain walkway connections to park add new high visibility cross walks
 - G - Mill Race Extension West**
 1. New Bituminous Asphalt Walks
 2. Interplanting of native riparian species near existing ash trees (per College at Oneonta Ash Tree Survey of Neahwa and Wilber Parks study and recommendations)
 - H - Mill Race Extension East**
 1. Extend walk along Mill Race
 2. Waterfront overlook
 3. Interplanting of native riparian species near existing ash trees (per College at Oneonta Ash Tree Survey of Neahwa and Wilber Parks study and recommendations)
 4. Incorporate planting on slopes
 5. Continue to monitor, clean, & maintain underpass.
